OFFICE ORDER

Subject: Bank Guarantee from the Industries/Projects/Processes/Activities for securing compliance of the provisions of the pollution control and environmental protection laws.

In pursuance of the decision taken in the 132nd Meeting of the State Board held on 16 February 2012, with a view to strengthen enforcement of the provisions of the pollution control and environment protection laws and encourage strict compliance thereof, by the Industries/Projects/Processes/Activities, it is considered essential that the consent application submitted by the management of the concerned Industry/Project/Process/Activity, that has earlier faced closure directions for non-compliance of the conditions stipulated in the relevant orders of the State Board, with respect to consent to establish and/or consent to operate (CTE and/or CTO), under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 or failure in submission of the renewal application(s) before the expiry of period of current CTE and/or CTO, the subsequent applications should only be processed/should be deemed to be incomplete, unless it is accompanied by the following:

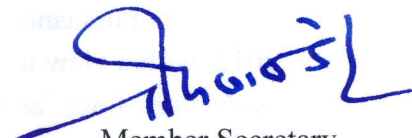
1. An affidavit, by the project proponent (including the owner/managers/persons in charge of and responsible for the operation of the Industry/Project/Process/ Activity), to the effect that it will ensure compliance of the conditions of CTE and/or CTO granted by the State Board.
2. A Bank Guarantee, in the name of the Member Secretary of the Board, equal to five (5) times of the amount, prescribed for yearly consent fee, subject to the condition that the bank guarantee shall not be for less than Rs. 10,000.00 (Rupees Ten Thousand Only).
 - Provided that in cases involving two consecutive non compliances a bank guarantee, in the name of Member Secretary of the Board, equal to ten (10) times of the amount, prescribed for yearly consent fee shall be submitted.
 - Provided further that, the Bank Guarantee, so submitted shall have validity for a period of one and half times of the duration for which, consent is sought (e.g. the validity of the Bank Guarantee shall be 18 months in case the consent is sought for one year).
 - Provided also that, the Bank Guarantee shall be forfeited by the State Board, upon proven non-compliance of any of the conditions stipulated in the letter of CTE and/or CTO, under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981.
 - Provided further that small industry/project/process/activity that fall in bracket of annual consent fee less than or equal to Rs. 1000 and not discharging any effluent/wastewater shall remain outside the purview of these provisions.

The aforesaid provisions relating Bank Guarantee shall become effective from 17th April, 2012.
